Important issue on MOAA National's radar:

1. Potential Government Shutdown on Sept. 30, 2025

Retirees and annuitants from the armed services would continue to receive pay during a government shutdown. (See related piece later in this newsletter)

As MOAA works to ensure those currently serving – in all branches – continue to receive pay during a shutdown, we will also work toward our cornerstone goal of service parity in these pay issues.

2. Pentagon Takes Another Step Toward Commissary Privatization:

Cost-cutting and privatization may offer short-term savings, but when the quality and integrity of a critical benefit are at stake, the consequences fall directly on servicemembers, veterans, retirees, and survivors.

# Halt TRICARE's Plan to End GLP-1 Coverage for TRICARE For Life

Support MOAA's efforts to protect GLP-1 weight-loss medications for retirees covered by TRICARE For Life.

#### Military Spouses Can't Wait - Add Them to the Work Opportunity Tax Credit

Military spouses face a 21% unemployment rate, five times the national average, due to frequent moves and challenges tied to military life. Congress must incentivize employers to hire military spouses by adding them as a target group under the Work Opportunity Tax Credit (WOTC) program.

# Ask Congress to Address the Hazardous Unaccompanied Housing Conditions Rampant in the Military

Thousands of servicemembers live in unsafe, substandard military housing due to years of underfunding and lack of oversight. Congress must require DoD to publicly report the condition of unaccompanied housing and ensure funding is used for necessary improvements.

# Stop the 34-Year Wait - Deliver Toxic-Exposed Veterans the Care They've Earned

Millions of veterans exposed to toxic substances during their service are forced to wait decades –more than 34 years, on average – before they can access VA care and benefits for service-connected illnesses. Congress must pass legislation to bolster the legal framework for creating presumptive conditions, ensuring toxic-exposed veterans receive timely care.

# Honor Veteran Caregivers - Pass the Reeducation, Reemployment, and Retirement Act

Veteran caregivers make profound personal and financial sacrifices to care for aging and disabled loved ones. Congress must pass the Veteran Caregiver Reeducation, Reemployment, and Retirement Act to provide these caregivers with the education, employment, and retirement support they deserve.

#### Fix the TRICARE Young Adult Coverage Gap

This bill would expand TRICARE eligibility to young adult dependents up to age 26, bringing TRICARE in line with commercial plan requirements.

# Ensure Servicemembers Can Afford Housing—Restore Full BAH

Our troops don't get to choose where they serve—but they should always be able to afford a home. Tell Congress to restore full Basic Allowance for Housing (BAH) and support military families.

#### Urge Lawmakers to Resume CFPB Operations for Servicemembers

Contact your representative and urge them to support the continued work of the Consumer Financial Protection Bureau (CFPB) in conducting supervisory examinations for the Military Lending Act (MLA) and resuming work in the Office of Servicemember Affairs, which protects military families from predatory financial practices.

# Stand with Our Wounded Warriors: Advocate for the Major Richard Star Act

Contact your representative and senators and urge them to support the Major Richard Star Act, which would authorize combat-injured veterans to receive their full DoD retirement pay earned for years of service and their full VA disability compensation for lifelong injury.

#### Don't Let Veterans' Life Insurance Fall Behind Inflation

Contact your senators and urge them to support the Fairness for Servicemembers and Their Families Act, which will require the VA to regularly review and update life insurance coverage limits for servicemembers and veterans, ensuring they keep pace with inflation and rising market costs.

# Parity for Surviving Spouses: Increase Dependency and Indemnity Compensation

Bipartisan legislation in the House (H.R. 2055) would align Dependency and Indemnity Compensation payments with other federal survivor benefits. Ask your legislators to show their support and make a long-overdue correction to this injustice.

#### Love Lives On: Protect Surviving Spouses' Right to Remarry

Contact your representative and senators and urge them to support the Love Lives On Act to secure the right for surviving military spouses to remarry at any age and retain their benefits.

# Support Leave Parity for USPHS Servicemembers

MOAA is committed to addressing parity gaps in U.S. Public Health Service (USPHS) Commissioned Corps benefits and personnel policy. Please join us in urging members of Congress to support legislation that would align USPHS Commissioned Corps leave policy with that of the other uniformed services.

#### Improve OB-GYN Access for Military Families

The TRICARE OBGYN Treatment and Access without Lags in Care Act (TOTAL Care Act) would launch a five-year pilot program allowing TRICARE Prime beneficiaries to receive obstetrical and gynecological care without a referral. Tell your lawmakers to support this effort to reduce delays and strengthen access within the TRICARE benefit.

#### Lend Your Support for the MOAA-Backed Bill to Support Military Sexual Trauma Survivors

Contact your representative and senators and urge them to support the Servicemembers and Veterans Empowerment and Support Act to improve essential care and services in the Veterans Health Administration and ensure greater assistance when military sexual trauma (MST) survivors are applying for disability benefits through the Veterans Benefits Administration.

#### Expand TRICARE Eligibility for Guard and Reserve

The Servicemember Healthcare Freedom Act would bring health care savings to thousands of servicemembers and their families by allowing Guard and Reserve members who are also federal employees to enroll in TRICARE Reserve Select.

Partnering with community providers, VA helps to ensure that Veterans can maintain independence and autonomy as they rise above the challenges of aging, disability or serious illness.

#### Resources for older Veterans

There are a variety of resources and programs for <u>older Veterans</u> that can help them build a routine and support system to remain independent.

- <u>Veteran Decision Aid</u> provides a checklist to help you narrow down which VA resources and what kind of care is best for you, with help creating a personalized health plan by and for Veterans like you.
- <u>Veteran Directed Care</u> allows you and your caregiver(s) to create an individualized plan for assistance and personal care that fits your needs and lifestyle. Through this program, you can get help developing a spending and care plan to help you live independently in your own home or community.
- <u>Palliative Care</u> focuses on keeping symptoms in check so that you can carry out day-to-day activities.
   Palliative care aims to improve your overall quality of life, whether that's physical, mental or emotional well-being.
- Adult Day Health Care is a VA support program designed to help with personal care tasks while also
  providing opportunities for you to socialize with others and engage in your community. These activities
  are flexible and can be adjusted to best fit your schedule and needs.

# **Community resources**

VHA also provides a wide range of community resources online, over the phone and in-person to help you find support and address specific needs. These include:

- Benefits Checkup is a free service that helps you identify what programs and care you qualify for.
- The <u>National Aging and Disability Transportation Center</u> promotes transportation options for older adults and caregivers, allowing more flexibility and freedom for senior Veterans.

#### What Would a Shutdown Mean for Retirement Pay?

Retirees and annuitants from the armed services would continue to receive pay during a government shutdown, but beneficiaries who served in the commissioned corps of the U.S. Public Health Service or NOAA lack such protections.

A passage in the FY 2021 National Defense Authorization Act (NDAA) moved Coast Guard military retiree pay under the Pentagon's Military Retirement Fund (MRF), which allows payments to continue during a funding lapse. While USPHS and NOAA retirees and annuitants are paid via the Coast Guard Pay and Personnel Center (PPC), they are not paid from the MRF. Their service-specific funding streams would be cut off until funding for respective agencies is restored.

# **October US Military History**

- **1648** Peter Stuyvesant established America's 1st volunteer firemen.
- 1775 The Continental Congress authorizes construction of the first American naval force
- **1779** Polish nobleman General Casimir Pulaski was killed while fighting for American independence during the Revolutionary War Battle of Savannah, Ga.
- **1797** The 44-gun 204-foot U.S. Navy frigate USS Constitution, also known as Old Ironsides, was launched in Boston's harbor.
- **1862** Dr. Richard Gatling patented a machine gun.
- **1863** The H. L. Hunley, the world's first successful combat submarine, sinks during a test run, killing its designer and 7 crew. She completed her last mission in 1864, when she sunk the USS Housatonic. The vessel was raised in 2000, and is now a museum piece.
- 1901 Theodore Roosevelt officially renames 1600 Pennsylvania Avenue as The White House
- 1916 US Army formed Reserve Officers Training Corps (ROTC).
- **1918** Sgt. Alvin C. York almost single-handedly killed 25 German soldiers and captured 132 in the Argonne Forest in France.
- **1947** Chuck Yeager becomes the first person to fly faster than the speed of sound, when he flies Glamorous Glennis, named in honor of his wife, over Rogers Dry Lake in California
- **1957** The Space Age and "space race" began as the Soviet Union launched Sputnik (traveler), the first manmade space satellite.
- **1962** A U.S. Air Force U-2 reconnaissance plane and its pilot fly over the island of Cuba and take photographs of Soviet missiles capable of carrying nuclear warheads being installed and erected in Cuba.
- **1972** A race riot occurs on the United States Navy aircraft carrier Kitty Hawk off the coast of Vietnam during Operation Linebacker.
- **1985** The leader of the so-called "Walker family spy ring," John Walker, pleaded guilty to giving U-S Navy secrets to the Soviet Union.
- 1993 American troops launch disastrous failed raid in Mogadishu, Somalia, later known as Black Hawk Down
- **2000** A motorized rubber dinghy laden with explosives blows a 40-by-40-foot hole in the side of the USS Cole, killing 17 sailors, wounding 38
- 2005 In a referendum vote, new Iragi constitution is ratified
- 2006 George W. Bush signs into law The Secure Fence Act of 2006 to build a fence along the U.S.-Mexico border.
- **2007** Time change from Daylight Savings to Standard time is changed from late October to early November, resulting in numerous technical glitches
- **2014** USS America (LHA 6), the Navy's newest and most technologically advanced amphibious assault ship, was commissioned during a formal ceremony during San Francisco Fleet Week.
